**FORMAT:** 2 rounds of 18 holes in a singles format. Each player may buy and use an unlimited amount of mulligans for each round. A player may only use one mulligan per turn. If a player uses a mulligan, he must play from that lie. This event will not be postponed or cancelled. This event will be a PDGA sanctioned C-Tier event and will be run in accordance to ALL PDGA rules. Since this event will be in a city park, drug and alcohol use WILL NOT be tolerated – no exceptions. If a player is found using any substances that go against PDGA guidelines before, during, or after the tournament he/she will be subject to disqualification without a refund.
